



Reporting Suspected Criminal Activity and Misconduct

Michigan State University (MSU) is committed to providing a safe and supportive environment for students, employees, and visitors. We encourage, and in some instances require, employees to report incidents of known or suspected criminal activity and misconduct. Please review the following information regarding reporting options and the University's prohibition on retaliation.

Relationship Violence, Sexual Misconduct, and Stalking

Responsible Employees are required to promptly report information about incidents or conduct that may be prohibited by the Relationship Violence and Sexual Misconduct and Title IX Policy (i.e., relationship violence, stalking, sexual misconduct (including sexual harassment, sexual assault, and sexual exploitation), and retaliation) that they observe or learn about in their working or professional capacity; and which occurred at a University-sponsored event or on University property or involves a member of the University community with respect to conduct that may have occurred while they were a member of the University community. Ethical, Policy, Compliance Violations and Other Misconduct

<p>The Misconduct Hotline does not replace University policy and reporting protocols regarding child abuse and other harm to children, relationship violence, sexual violence, stalking, and sexual exploitation. While such issues may be referred to the Misconduct Hotline, employees are also required to follow the reporting protocols related to child abuse and RVSM.</p>	
Student Misconduct

Hazing	

<p>Anyone who becomes aware of prohibited hazing conduct is encouraged to immediately report the incident, including all observed or learned details.</p> <ol style="list-style-type: none"> 1. Report any incident involving a crime, an emergency, or imminent threat to health or safety to the police. 2. Report acts or potential acts of hazing that do not constitute an emergency to OSSA. 3. Office of the University Ombudsperson

Whether one is a student or employee, the [Office of the University Ombudsperson](#) offers a confidential place to discuss academic concerns, administrative issues, workplace issues, or any concern that may impact their experience at the university. NON-RETALIATION

Prohibition of Retaliation for Reports Related to Civil Rights

The [University prohibits retaliation](#) (including retaliatory harassment) against individuals who report or make good faith complaints of relationship violence, stalking, sexual misconduct, discrimination, harassment, and other forms of misconduct (as specifically governed by individual University policies), or who participate in the University's investigation and handling of such reports, even if the University finds that no violation of Policy occurred. In addition, the laws that prohibit discrimination and harassment contain anti-retaliation provisions (e.g., Title VII, Title IX, ELCRA, etc.). Specifically, Title IX prohibits retaliation against reporters of sex discrimination, including reports of sex discrimination against administrators and other employees. MSU independently investigates allegations of retaliation and will take strong responsive actions if retaliation occurs. Concerns of civil rights-related retaliation should be reported immediately to the Investigation, Support and Resolution Department, or ISR, [Office for Civil Rights and Title IX Education and Compliance \(OCR\)](#).

Prohibition of Retaliation for Other Reports of Misconduct (non-civil rights related)

[MSU policy](#) also prohibits community members from engaging in retaliation against students and employees who report other types of misconduct (non-civil rights related), or who participate in investigations or reviews of other types of misconduct. Those found responsible for retaliation may be subject to disciplinary action up to and including termination for employees. Individuals are encouraged to report incidents of retaliation that they observe or learn about by contacting one of the following:
